

Welcome to our new members

WASHINGTON — Vietnam advised the United States at the start of high-level talks this week it would open four additional sites to investigators seeking the remains of American military personnel missing since the Vietnam War, a senior U.S. defense official said.

Deputy Assistant Defense Secretary Vikram Singh, who oversees U.S. military ties with South and Southeast Asia, said an eight-member delegation led by Senior Lieutenant General Nguyen Chi Vinh told U.S. defense officials about the decision at the outset of talks at the Pentagon this week.

"They basically opened the meeting by turning over the information and providing us access to an additional four sites for remains recovery operations to go look for our fallen," said Singh, calling it a "really meaningful" gesture.

A U.S. official said on Friday the sites were in the southern part of Vietnam and were small areas where specific incidents are believed to have taken place. Officials declined to elaborate, citing concerns for the families of the missing.

The Defense Department's POW/Missing Personnel Office says 1,643 Americans remain unaccounted for from the Vietnam War, including 1,275 in Vietnam and the rest in Laos, Cambodia and China. The office has investigated 600 of the Vietnam cases and believes it will not be possible to recover the remains, leaving 675 still being sought in that country.

Vinh's delegation visited the Pentagon for talks that take place annually between the former enemies, which have been deepening military ties over the past decade.

The pace of contact between the two countries has increased in recent years as the United States has moved to refocus its energies on the Asia-Pacific region after more than a decade of war in Iraq and Afghanistan. The rebalancing takes place amid concerns among Washington and Asian allies about China's growing assertiveness in the region.

Then-U.S. Defense Secretary Leon Panetta visited Vietnam last year, stopping at Cam Ranh Bay to visit a U.S. Navy supply vessel undergoing repairs, before traveling to Hanoi for talks with senior defense leaders.

"In the year since then, what we've seen is just an across-the-board deepening of defense ties," Singh said in an interview this week. He noted that Secretary of State John Kerry and Defense Secretary Chuck Hagel both served in the Vietnam War and had a special interest in the country.

The United States and Vietnam have been cooperating in five areas since signing a memo of understanding in 2011: peacekeeping, maritime security, humanitarian assistance and disaster response, search and rescue, and high-level exchanges.

Singh said the two countries had been increasing cooperation on peacekeeping over the past year after Vietnam changed its laws and regulations to permit its military forces to participate in international peacekeeping operations.

"We see it as in our interest for all the Southeast Asian nations to be active supporters and contributors to peacekeeping operations," he said.

The two sides also set the stage for further cooperation on maritime security during the visit, Singh said. Admiral Robert Papp, commandant of the Coast Guard, and Major General Nguyen Quang Dam, commander of Vietnam's coast guard, signed an agreement formalizing their decision to work together on equipment, training and capacity building.

"Having this cooperation is an opportunity for us to work together with them on things that we think will help contribute to overall peace and stability in the South China Sea," said Singh.

(Washington, DC) – "Among the so-called invisible wounds of war are those brought home by troops that may not manifest for a decade or more," said John Rowan, National President of Vietnam Veterans of America(VVA). "Tragically, these wounds may be passed on genetically to the progeny of our nation's warriors, as we are well acquainted with having been exposed to Agent Orange."

"Therefore we welcome the introduction of S.1602, the Toxic Exposure Research and Military Family Support Act of 2013, which has just been introduced by Senator Richard Blumenthal (D-CT). This legislation would establish within the Department of Veterans Affairs a national center for the diagnosis, treatment, and research of the health conditions of the progeny of veterans exposed to toxic substances during their service in the Armed Forces, and to provide diagnostic treatment and care to them," Rowan said.

"VVA strongly supports this bill, which reflects positively on one of our foremost legislative goals. Not only will its enactment help achieve a measure of justice for the innocent victims of the use of toxic substances in times of war, but it offers significant opportunities for scientific research into the intergenerational effects of these toxic chemicals," noted Rowan. This legislation would also establish an Office of Extramural Research, to award grants to reputable scientists and epidemiologists to conduct research on wounds, illnesses, injuries, and other conditions suffered by individuals as a result of exposure to toxic substances while serving as members of the Armed Forces.

"Ask the Department of Veterans Affairs how many studies its hundreds of scientists are conducting in this realm. Ask the NIH. And the CDC," Rowan challenged. "Finally, we offer our sincere thanks to Sen. Blumenthal, for his

empathy and for his vision. His legislation gives hope to the progeny of warriors who are suffering from health conditions which we believe may derive from exposure to toxic substances."

"Because of our ongoing struggle with the unfortunate legacy of Agent Orange, and because of our empathy for veterans of other conflicts, including the first Gulf War, with their still-undefined Gulf War illnesses, and the wars in Afghanistan and Iraq, where exposure to fumes from burn pits will be their unwanted legacy, we will pull out all stops to work to ensure passage of S. 1602, and to see that companion legislation is introduced in the House," Rowan concluded.

Vietnam Veterans of America (www.vva.org) is the nation's only congressionally chartered veterans service organization dedicated to the needs of Vietnam-era veterans and their families. VVA's founding principle is "Never again will one generation of veterans abandon another."

VA Offers Dental Insurance Program

WASHINGTON (Nov. 13, 2013) – VA is partnering with Delta Dental and MetLife to allow eligible Veterans, plus family members receiving care under the Civilian Health and Medical Program (CHAMPVA), to purchase affordable dental insurance beginning Nov. 15, VA officials announced today.

"VA continues to explore innovative ways to help Veterans get access to the care and services they have earned and deserve," said Secretary of Veterans Affairs Eric K. Shinseki. "This new dental program is another example of VA creating partnerships with the private sector to deliver a range of high-quality care at an affordable cost, for our Nation's Veterans."

More than 8 million Veterans who are enrolled in VA health care can choose to purchase one of the offered dental plans. This three-year pilot has been designed for Veterans with no dental coverage, or those eligible for VA dental care who would like to purchase additional coverage. Participation will not affect entitlement to VA dental services and treatment.

There are no eligibility limitations based on service-connected disability rating or enrollment priority assignment. People interested in participating may complete an application online through either Delta Dental, http://www.deltadentalvadip.org/, or MetLife, http://www.metlife.com/vadip beginning Nov. 15. Coverage for this new dental insurance will begin Jan. 1, 2014, and will be available throughout the United States and its territories.

Also eligible for the new benefits are nearly 400,000 spouses and dependent children who are reimbursed for most medical expenses under VA's CHAMPVA program. Generally, CHAMPVA participants are spouses, survivors or dependent children of Veterans officially rated as "permanently and totally" disabled by a service-connected condition.

Dental services under the new program vary by plan and include diagnostic, preventive, surgical, emergency and endodontic/restorative treatment. Enrollment in the VA Dental Insurance Plan (VADIP) is voluntary. Participants are responsible for all premiums, which range from \$8.65 to \$52.90 per month for individual plans. Copayments and other charges may apply.

Historically VA's free dental services have gone to Veterans with dental problems connected to a medical condition that's officially certified as "service connected." Free dental services will continue for those Veterans..

The practice of referring to the American flag as "Old Glory" was coined by Captain William Driver, a shipmaster of Salem, Massachusetts. As he was leaving on August 10, 1831 on one of his many voyages aboard the brig CHARLES DOGGETT - a voyage that would climax in the rescue of the mutineers of the BOUNTY - some friends presented him with a beautiful flag of twenty-four stars. As the banner opened to the ocean breeze for the first time, he exclaimed "Old Glory!"

He retired to Nashville in 1837, taking the treasured flag from his sea days with him. By the time the Civil War erupted, most everyone in and around Nashville recognized Captain Driver's "Old Glory." When Tennessee seceded from the Union, Rebels were determined to destroy his flag, but repeated searches revealed no trace of the hated banner.

Then on February 25th, 1862, Union forces captured Nashville and raised the American flag over the capital. It was a rather small ensign and immediately folks began asking Captain Driver if "Old Glory" still existed. Captain Driver went home and began ripping at the seams of his bedcover. As the stitches holding the quilt-top to the batting unraveled, the onlookers peered inside and saw the 24-starred original "Old Glory"

Captain Driver gently gathered up the flag and returned with the soldiers to the capitol. Although he was well along in years, the captain climbed up to the tower to replace the smaller banner with his beloved flag. The Sixth Ohio Regiment cheered and saluted - and later adopted the nickname "Old Glory" as their own.

VIETNAM VETERANS OF AMERICA WESTCHESTER COUNTY CHAPTER #49 SCHOLARSHIP AWARDS PROGRAM

Vietnam Veterans of America - Chapter #49, awards six scholarships of \$700 each year to high school graduates in Westchester County. The awards are granted to assist with a college or vocational school education. These scholarships honor six outstanding individuals from our area and are named the Pete Lambert Memorial Scholarship, the Congressman Hamilton Fish Jr. Memorial Scholarship, the Peter T. McCauley Memorial Scholarship, the Anthony Shine Memorial Scholarship, the Jonathan Shine Memorial Scholarship, and the William Suddereth Memorial Scholarship.

ELIGIBILITY: Students who will complete high school in Westchester County this year, are the child or a grandchild of an active duty service veteran, and plan to attend an accredited U.S. college/university or vocational/technical school are eligible to compete for the scholarships. **Please note** that service in the Reserves or National Guard does not constitute veteran status, unless you were activated for more than 90 days for purposes other than training. **Also note** that the child of any veteran is eligible; service does not have to be during the Vietnam era.

HOW TO APPLY: There are four selection criteria that the student must submit in order to be considered for a scholarship:

- 1. Junior year rank in class.
- 2. Scholastic Aptitude Test (SAT) scores; no other test score will be accepted. **Note**; for those who will be attending a vocational/technical school this requirement will be waived.
- 3. A resume of extracurricular activities to include school clubs, sports and student government, work experience, volunteer experience and other interests. Relevant references, with addresses and phone numbers, should be provided.
- 4. A written statement, not to exceed two typed pages, on the topic "The affect (if any) of my mother's/father's military service on my attitudes toward life and country."

SELECTION OF AWARDEES AND PRESENTATION OF SCHOLARSHIPS: VVA #49 Scholarship Committee is solely responsible for the selection process. In late May the Committee will notify those selected for scholarships and their high schools and the acceptance and enrollment of those selected in an accredited college or technical school will be verified. Scholarship awards will be presented at a meeting of VVA #49 during the summer.

IMPORTANT ITEMS: Application must be submitted by April 1, 2014 and must include a copy of parents DD-214 (military discharge). Principal or guidance counselor must certify your rank in class and SAT score; a copy of your SAT score must be included. Include the phone number of your high school and make sure the application is complete. THE SCHOLARSHIP COMMITTEE WILL NOT CONSIDER APPLICATIONS THAT DO NOT CONTAIN ALL OF THE REQUESTED INFORMATION IN ITS REQUIRED FORM OR ARE RECEIVED AFTER THE SUBMITTAL DATE.
