

#### VA Loans D How to Save on Closing Costs

Closing costs are an inherent part of any VA home loan. Processing and approving a VA home loan application requires information and services from more than just your VA lender. And if you don't watch out, you'll pay more than you have to. VA loans limit the types of closing costs that veterans can pay but even with those limitations, there are closing costs. Here are some ways to reduce or avoid paying for them altogether.

**Closing Costs the VA Allows.** One of the easiest ways to remember the fees that the veteran may pay for is by using the acronym ACTORS. This stands for appraisal, credit report, title insurance, origination fees, recording and survey or abstract charges. The VA funding fee is also a charge but may be rolled into the loan amount and not paid out of pocket. This list leaves a lot of other players out of the picture and is an advantage that eligible VA borrowers have that others do not. What sort of fees? Common fees charged that veterans are not allowed to pay include loan processing, loan underwriting, document prep fees, escrow charges, settlement fees and a host of others. Added up, these fees can be more than a few thousand dollars, depending upon the size of the loan amount, locale and other factors. So how much can the fees be for the charges that the veteran is allowed to pay? Using a home with a sales price of \$300,000, what you might see is Appraisal \$500; Credit report \$50; Title \$3,000; Origination \$3,000; and Recording \$100 for a total of \$6,650. Even though VA loans limit the amount of costs the veteran may pay, it still can be a sizable number.

How to Save or Eliminate Fees. You always try one of the following. Nothing ventured, nothing gained. • Seller Concessions. The most convenient way is to have the seller pay them. When making an offer on a home, your agent can ask that the seller pay a certain percentage or a particular amount of your closing costs. VA guidelines allow a seller to pay up to 4 percent of the sales price of the home to go directly toward the veteran's closing costs. In the above mentioned example, that could be up to \$12,000, well above what the borrower might pay. If not all of the costs, perhaps just some of them. If your offer says something to the effect of "We'll pay your asking price but we want you to pay all of our closing costs up to 4 percent of the sales price." In this scenario the seller's only choices are to pay all, some, or none of them

• Lender Credit. Another way to reduce or eliminate VA loan closing costs is having the lender provide a lender credit. How does a lender credit work? When speaking with your loan officer about various interest rate options, along with a loan term such as a 30 or 15 year fixed, you will also be given a list of rates with points and rates without points. Points, called "discount points" in the industry, are represented as a percentage of the loan amount. For each point paid, the interest rate can be reduced by about one-quarter of one percent on a 30 year mortgage. You might be quoted something like, "4.50 percent with no points or 4.25 percent with one point." On a 30 year loan of \$300,000, one point will cost you \$3,000.

Conversely, a lender can actually increase your interest rate by one-quarter of one percent or more, and provide you with a lender credit to be applied to your closing costs. Using this same example, you might be quoted 4.50 percent with no points, 4.75 percent with no points and a \$3,000 credit or 5.00 percent for a \$6,000 lender credit. It's your choice and something you need to review with your lender. Your monthly payment will be slightly higher, but then again you saved \$6,000.

There's no getting around closing costs on a VA loan, it's simply a matter of who pays for them. Properly structured, you may not have to. [Source: Mil.com | VA Loan Captain | Sep 2013 ++]

# Landmark open meeting on Agent Orange held at Oregon VA hospital

Nov 22 (Reuters) - Vietnam War veterans on Saturday called for more research into the health effects of U.S. service members' exposure to Agent Orange, in a first of its kind open meeting at a VA hospital in Portland, Oregon, on the lingering effects of the chemicals. The U.S. military during the Vietnam War sprayed millions of gallons of Agent Orange to destroy foliage and expose enemy troops. The herbicide, nicknamed for its giant orange storage drums, was often contaminated with a type of dioxin, a potently carcinogenic chemical. About 130 veterans attended the meeting at the U.S. Department of Veterans Affairs Medical Center in Portland. It was the first time the VA allowed the nonprofit Vietnam Veterans of America to hold an Agent Orange town hall at one of its hospitals, said Mokie Porter, spokeswoman for the group. Research has suggested U.S. veterans exposed to Agent Orange are at increased risk of high blood pressure, lymphoma, prostate cancer and other illnesses. Agent Orange has also been linked to birth defects in children of those exposed to it. The VA provides health care to children of veterans who can link health conditions such as spina bifida to their Agent Orange exposure. Advocates with Vietnam Veterans of America believe more research would show health consequences go further than what the U.S. government acknowledges. Many veterans are still not aware of the full effects of exposure, Porter said. At the town hall meeting, U.S. Air Force veteran Jack McManus said he knew a master sergeant who tried to demonstrate the chemical was safe by gargling with it."We were told it wasn't harmful," said McManus, who traveled from North Carolina to speak at the event. "More research is needed to understand how children and grandchildren might be affected. "McManus said: "We need to get toxic research bills passed and through the Congress and signed by a president of the United States." His remarks drew shouts of "you've got that right" from veterans in attendance. Dan Herrigstad, spokesman for the VA in Portland, said he does not know why other hospitals in the United States have not hosted similar events. "It's part of the mission of the VA. That's why our director agreed to it," he said.

The U.S. government in 2012 began working to clean up Agent Orange in Vietnam.

# VIETNAM VETERANS OF AMERICA WESTCHESTER COUNTY CHAPTER #49 SCHOLARSHIP AWARDS PROGRAM

Vietnam Veterans of America - Chapter #49, awards six scholarships of \$700 each year to high school graduates in Westchester County. The awards are granted to assist with a college or vocational school education. These scholarships honor five outstanding individuals from our area and are named the Pete Lambert Memorial Scholarship, the Congressman Hamilton Fish Jr. Memorial Scholarship, the Peter T. McCauley Memorial Scholarship, the Anthony Shine Memorial Scholarship, the Jonathan Shine Memorial Scholarship, and the William Suddereth Memorial Scholarship.

**ELIGIBILITY:** Students who will complete high school in Westchester County this year, are the child or a grandchild of an active duty service veteran, and plan to attend an accredited college/university or vocational/technical school are eligible to compete for the scholarships. **Please note** that service in the Reserves or National Guard does not constitute veteran status, unless you were activated for more than 90 days for purposes other than training. **Also note** that the child/grandchildof any veteran is eligible; service does not have to be during the Vietnam era.

**HOW TO APPLY:** There are four selection criteria that the student must submit in order to be considered for a scholarship:

- 1. DD-214 or honorable discharge of parent/grandparent
- 2. SAT/ACT scores; no other test score will be accepted. **Note**; for those who will be attending a vocational/technical school this requirement will be waived.
- 3. A resume of extracurricular activities to include school clubs, sports and student government, work experience, volunteer experience and other interests. Relevant references, with addresses and phone numbers, should be provided.
- 4. A written statement, not to exceed two typed pages, on the topic "The affect (if any) of my parent's/grandparent's military service on my attitudes toward life and country."
- 5. Application must be signed by student, parent/guardian and School staff.

**SELECTION OF AWARDEES AND PRESENTATION OF SCHOLARSHIPS:** VVA #49 Scholarship Committee is solely responsible for the selection process. In late April the Committee will notify those selected for scholarships and their high schools and the acceptance and enrollment of those selected in an accredited college or technical school will be verified. Scholarship awards will be presented at our May meeting.
