# Optometry and Audiology and Direct Scheduling Roll-Out

### Background

The MyVA Performance Improvement Team has been working with VA medical centers across the country to identify performance improvement opportunities and pilot programs that can positively impact the Veteran and employee experience. One opportunity, identified during sites visits, is the direct scheduling of patients in need of Optometry (eye) and Audiology (hearing) services without referrals though their respective Primary Care providers.

In 2015, VA launched pilots in three locations: Bay Pines VA Healthcare System (VAHCS), White River Junction, VT and Mountain Home, TN. The pilots gave Veterans (including traveling Veterans and those unassigned to a Primary Care provider) the option to directly schedule routine Optometry and Audiology appointments without the need for a Primary Care consult. Because of the success of the pilots, we are now making this program available to Veterans at our facility.

As part of a national VA roll-out, Direct Scheduling available across VA Hudson Valley Health Care System will be starting for **Optometry on August 22** and **Audiology on September 12**.

#### What Did Veterans and Staff Gain from the Pilot?

Veterans involved in the pilot indicated that they like the new process. Those not needing a Primary Care visit saved a trip to the facility. When taking into account the elimination of the Primary Care appointment, Veterans total wait times were reduced appreciably. Employees scheduling appointments saved on average an hour a day reviewing consults and setting up appointments. Primary Care Physicians had clinical time freed up.

# VIETNAM VETERANS OF AMERICA WESTCHESTER COUNTY CHAPTER #49 SCHOLARSHIP AWARDS PROGRAM

Vietnam Veterans of America - Chapter #49, awards six scholarships of \$700 each year to high school graduates in Westchester County. The awards are granted to assist with a college or vocational school education. These scholarships honor six outstanding individuals from our area and are named the Pete Lambert Memorial Scholarship, the Congressman Hamilton Fish Jr. Memorial Scholarship, the Peter T. McCauley Memorial Scholarship, the Anthony Shine Memorial Scholarship, the Jonathan Shine Memorial Scholarship, and the William Suddereth Memorial Scholarship.

**ELIGIBILITY:** Students who will complete high school in Westchester County this year, are the child or a grandchild of an active duty service veteran, and plan to attend an accredited U.S. college/university or vocational/technical school are eligible to compete for the scholarships. **Please note** that service in the Reserves or National Guard does not constitute veteran status, unless you were activated for more than 90 days for purposes other than training. **Also note** that the child or grandchild of any veteran is eligible; service does not have to be during the Vietnam era.

**HOW TO APPLY:** There are three selection criteria that the student must submit in order to be considered for a scholarship:

- 1. You're SAT or ACT scores; no other test score will be accepted. **Note**; for those who will be attending a vocational/technical school this requirement will be waived.
- 2. A resume of extracurricular activities to include school clubs, sports and student government, work experience, volunteer experience and other interests. Relevant references, with addresses and phone numbers, should be provided.
- **3.** A written statement, not to exceed two typed pages, on the topic "The affect (if any) of my mother's/father's or grandfather's/grandmother's military service on my attitudes toward life and country."

Students should complete the attached application and return it, along with the other requested items, by **April 1, 2017** to: Vietnam Veterans of America #49

**SELECTION OF AWARDEES AND PRESENTATION OF SCHOLARSHIPS:** VVA #49 Scholarship Committee is solely responsible for the selection process. In late May the Committee will notify those selected for scholarships and their high schools and the acceptance and enrollment of those selected in an accredited college or technical school will be verified. Scholarship awards will be presented at our May meeting.

**IMPORTANT ITEMS:** Application **must be submitted by April 1, 2017** and must include a copy of parent's or grandparent's DD-214 (military discharge). Principal or guidance counselor must certify your rank in class and SAT score; a copy of your SAT or ACT score must be included. Include the phone number of your high School and make sure the application is complete. <u>THE SCHOLARSHIP</u> <u>COMMITTEE WILL NOT CONSIDER APPLICATIONS THAT DO NOT CONTAIN ALL OF THE REQUESTED INFORMATION IN ITS REQUIRED FORM OR ARE RECEIVED AFTER THE SUBMITTAL DATE.</u>

# Veterans' Diseases Associated with Agent Orange



VA assumes that certain diseases can be related to a Veteran's qualifying military service. We call these "presumptive diseases."

VA has recognized certain cancers and other health problems as presumptive diseases associated with exposure to Agent Orange or other herbicides during military service. Veterans and their survivors may be eligible for benefits for these diseases.

#### • AL Amyloidosis

A rare disease caused when an abnormal protein, amyloid, enters tissues or organs

#### • Chronic B-cell Leukemias

A type of cancer which affects white blood cells

• Chloracne (or similar acneform disease)

A skin condition that occurs soon after exposure to chemicals and looks like common forms of acne seen in teenagers. Under VA's rating regulations, it must be at least 10 percent disabling within one year of exposure to herbicides.

• Diabetes Mellitus Type 2

A disease characterized by high blood sugar levels resulting from the body's inability to respond properly to the hormone insulin

• Hodgkin's Disease

A malignant lymphoma (cancer) characterized by progressive enlargement of the lymph nodes, liver, and spleen, and by progressive anemia

• Ischemic Heart Disease

A disease characterized by a reduced supply of blood to the heart, that leads to chest pain

• Multiple Myeloma

A cancer of plasma cells, a type of white blood cell in bone marrow

• Non-Hodgkin's Lymphoma

A group of cancers that affect the lymph glands and other lymphatic tissue

#### • Parkinson's Disease

A progressive disorder of the nervous system that affects muscle movement

• Peripheral Neuropathy, Early-Onset

A nervous system condition that causes numbress, tingling, and motor weakness. Under VA's rating regulations, it must be at least 10 percent disabling within one year of herbicide exposure.

• Porphyria Cutanea Tarda

A disorder characterized by liver dysfunction and by thinning and blistering of the skin in sun-exposed areas. Under VA's rating regulations, it must be at least 10 percent disabling within one year of exposure to herbicides.

Prostate Cancer

Cancer of the prostate; one of the most common cancers among men

- Respiratory Cancers (includes lung cancer) Cancers of the lung, larynx, trachea, and bronchus
- Soft Tissue Sarcomas (other than osteosarcoma, chondrosarcoma, Kaposi's sarcoma, or mesothelioma)

A group of different types of cancers in body tissues such as muscle, fat, blood and lymph vessels, and connective tissues.

# **COINS ON A HEADSTONE**

A coin left on a headstone lets the deceased soldier's family know that somebody stopped by to pay their respect. Leaving a penny means you visited. A nickel means that you and the deceased soldier trained at boot camp together. If you served with the soldier, you leave a dime.
